	intellectual difficulties and very low skills. They also work	
	(directly or associated) with probation services so their	
	competences is a complement with such target groups than CAPTIVE ones.	



Experiences of similar actions in relation to role in the implementation of the proposed action	In EU projects Euro-CIDES often lead with (national and transnational) coordination but also with communication and dissemination. We have experiences in project's evaluations and our contact person is an independent expert of GRUNDTVIG/ERASMUS+ French NA since 2010. Euro-CIDES leads diagnosis of social needs on territories on behalf of municipalities so to help decision makers to be aware of the evolution of their population. We are authorized by the ministry of health to audit medico-social institutions hosting elderly people, mentally disabled persons, juveniles and young adults under penal measures mainly with educative measures Euro-CIDES has very good knowledge of social networks and is able to give link and sense to new political stakes.
History of cooperation with University of Malta as coordinating organization	Faculty of Social Wellbeing University of Malta and Euro-CIDES we were both partners in a GRUNDTVIG Multilateral project titled "Finding Education for Female Inmates (FEFI)" which gave them voice inside their prisons (10 partners from 8 EU countries and associated) to decide about their future post-released project by choosing topics' training so to prepare their reintegration into society.

Together we will be responsible for the monitoring and communication activities of the project. Collaborating with the Steering committee, Euro- CIDES will coordinate and create the monitoring and evaluation plan - evaluation criteria and survey tools (to verify the quality, the satisfaction and the results of each step of the project).
	Euro-CIDES will also be involved in WS1 – WS2 – WS4 actions: - Research activity. Researchers will define the state of the art on the local territory in relation to the S/GBV phenomenon in migrant communities including - S/GBV cases and perspectives, resilience strategies, national law system to defend victims of S/GBV, support services, networks to support migrant women victims of gender violence etc; - Realization of two technical workshops to create awareness amongst participants, especially those working in support services, for which Euro-CIDES must select a minimum of 20 professionals;
	 Prevention activities to fight and promote prevention policies against S/GBV. For this action Euro-CIDES will organize: three workshops for communities, working with vulnerable groups such as refugees, asylum seekers and international protection seekers; the final EU conference for institutions, professional experts to share and promote the results obtained;
