Objectives and regular activities	ANFE is a National Association based in Rome organized with 48 foreign representatives, covering 16 countries. In Italy the body is made up of 44 provincial and 16 regional structures. ANFE is registered for the Register of Institutions and Associations performing activities in favor of immigrants (Ministry of Labour and Social Policies); General Directorate of Immigration; UNAR Registry, the Registry of associations and to support the fight against the discrimination (Presidency of the Council of Ministers - Department for Equal Opportunities). ANFE is one of the founders of the National Emigration Council (CNE). It's menber of the General Council of the Union International des Organismes familiaux, of Comites and of the General Council of Italians Abroad (CGIE). It partecipates actively in the tables of the Territorial Councils for Immigration and It's also part of the Institute for International Economic Cooperation and the Problems of Development. One of the main activities of A.N.F.E. in the world is developing new inclusion policies in order to promote the social integration of migrant communities in the hosting countries. For that reason in the last few years ANFE, answering to the social inclusion needs of the new migration flows come from Africa and Arabic Countries, has organized language and culture courses for migrants and refugees.

It has a long career within the educational, vocational training and LLL, especially in Sicily where through a staff of experts has realized training for professionals, continuous training, educational and vocational training courses, career counseling and job services for disadvantage people such as unemployed, migrants, women, people with disabilities, minors a risk of no school attendance, drug addict and prisoners.

ANFE has developed over the years a lot of educational and training initiatives within the nature of prison, therapeutics community and recovery in order to ensure to persons in detention new social integration processes through the development of new knowledge and awareness and the redefinition of their social and professional identity. This competence together with the collaboration of the local Penal Institutes such as the Ucciardone in Palermo and the Penitentiary in Castelvetrano will match the needs of the project. Since 2002 ANFE has developed vocational training activities for prisoners inside many Sicilian Penitentiaries such as the prison in Agrigento, Enna, Piazza Armerina, Nicosia, Gazzi, Catania, Giarre, Trapani, Castelvetrano and the forensic psychiatric hospital in Barcelona Pozzo di Gozzo. Moreover in 2010 with the three years project In&Out has realized a vocational guidance and training activities inside the Penitentiary for the penal institute for minor in Palermo, Catania, Acireale and Caltanissetta. This has meant that ANFE could improve and extend its know how in educational and

	Ws2 Learning activities - 3 Months. In each partner country, two workshops about the following topics will take place: · S/GBV and the promotion of equality; · S/GBV: law and cultures · S/GBV: De-victimization and reparative systems . A gender sensitive survival approach will be adopted A minimum of 10 professionals and service providers per country will take part in these workshops. Such professionals will be staff providing specialized victim support and who are first points of contact for victims of violence (police, probation officers, lawyers etc.) in order to enhance the knowledge of S/GBV and to strengthen programs combating gender-based violence among migrants. The workshops will be divided in two parts: Part 1 - presentation of the main topic of the meeting, the state of the art and possible systems of support forS/GBV victims Part 2 - active participation to propose possible social policies, empowerment strategies to support migrant victims of S/GBV and to develop new networks Story Telling Activity - In Germany, Italy and Malta, three days of Storytelling Activities. The first level of engagement focuses on experiential learning. The activities will aimed at creating an environment where people can explore their perceptions about S/GBV, related issue and better understand the challenges posed by the violence they go through. Selected stories will be shared as a dialogue tool for advocating against harmful



attitudes and practices that affect women negatively. The most important objective is for the target group to attend as participants and the expected result would be the creation of a video. Training activity – 3 Months (MTS 11-13) (Objectives 2&4) The training activity starts from this common point and it will provide two training courses: A. "Ethno-cultural Agent" Course (150 Hours)aimed at a group of migrant women, victims or potential victims of violence, (maximum 5 people in each country) identified through the migrant communities. The course will address: cases of gender violence; cultural codification of gender violence; the European/national law against the crime of S/GBV; empowerment of victims and resilience and coping strategies. Secondly, participants will be involved in an interactive activity, conducted by an expert and an intercultural mediator. They will operate through the methodology of the storytelling or digital storytelling. At the end participants could work either with the courts or in systems that support victims of S/GBV as ethno-cultural agents. B.
