Presentation of Ethno-Cultural Agent course shown in Sevilla (to other project partners): **Ethno-cultural agent course in Malta**

The presentation has 31 slides with a brief presentation of some subjects.

Presentation of the participants: 4 to 8 migrant women. Most Libyan, 1 Palestinian (but brought up in Libya), 1 Somalian. Age: 25 – 50. All Muslim. Most received university education. A variety of immigration statuses. Recruited through a local NGO

On each slide, the speaker gives his representation and questions. For exemple: "One thing that I've been reflecting on for a while through interaction with them is - why are they taking this course? I suppose at the end we will have a better idea of why since we plan on asking them - emerged as the course went on, is that these women take a variety of courses, such as cooking courses, English courses, IT courses. They strive to improve themselves and also they want to keep busy. Because most of them cannot do their job, since their qualifications are not recognised in Malta and they would have to take conversion exams and potentially go back to studying. Applies to all participants. Keeping busy - rejected asylum seekers - they can work in Malta - busy - I don't have to think. University - being there

Topics were:

- 1- Being busy
- 2- Uncertainty
- 3- What is home
- 4- Bringing kids up in a foreign country (Many of the women see this as a big challenge)
- 5- What makes you a woman?
- 6- The Hijab / discrimination
- 7- Violence and understandings of violence







Tools for the course

- Antenatal (prenatal) care from Salma Ghath; Content 12 slides with brief explication of this special time. This presentation was made on September 7th.
- Basic Knowledge on Breastcancer from Slama Ghath. 13 slides about breast anatomy, facts,non cancerous conditions, how do we get a cancer? mortality and survival rates for BC, Early restection, signs, exam; treatments,
- Fertility awareness and contraception. 13 slides. Present the different choice for the contraception.

Womens circle logbook of professionals compiled by one member of the Malta group.

40 pages which present notes taken in every sessions. They anonymously profile people, the interaction and the important elements which are coming out. Every session presents at the end the comments of the speaker, which give the personal and professional feeling of the situations, and the evolution of the sessions. Very interesting document. Some extract could be used as tools exemple for the other professionals.

Notes for the contents of the course

DEMOCRACY

- . Interactive works : writing a word, like citizenship on the board and elicit as many words as possible
- . Some definition. Exemple : State with a brief historic, democracy with a long explanation, citizenship.

We can see that the course have been done with a choice of interaction with the persons.

Evaluation from Senior expert / Malta

Write a little introduction with the summary and then a little 5-10 lines summary for each topic.

Organise the contents of the courses to have them in a simple access. It could used later as a box with the other coutrnies tolls.

Realise a little book with the notes and the questions of the professionels. It could become a tools for other professionnals.
